Sex, Drugs and Viral Load: HIV
Prevention for People Living with

Potent and effective treatments for HIV infection first became available in 1996 and these combinations of medications have revolutionized treatment and care for people diagnosed with HIV infection. People with HIV infection now live longer and healthier lives than ever before. With the advent of new treatments, so too has the scope of HIV prevention changed, with a new focus on HIV positive persons as the target for prevention. In 2003 the Centers for Disease Control and Prevention directed HIV prevention for people infected with HIV as the national HIV prevention priority. Unfortunately, current evidence-based behavioral interventions for reducing HIV transmission risks among people living with HIV are often not well integrated with HIV treatments or treatment adherence, even when HIV prevention activities are delivered in clinical care settings. Medication adherence, viral load, infectiousness, and perhaps most importantly perceived infectiousness are not included in evidence-based interventions for reducing HIV transmission risk behavior among people living with HIV/ AIDS. This Master Lecture reviews the empirical rationale for integrating medication adherence and perceived infectiousness in HIV prevention interventions for people living with HIV/AIDS and presents a model for such an integrated intervention.

Behavioral Economics of Activity and Eating Choices in Youth: Their Impact on Pediatric Obesity

Youth are becoming more obese, and more sedentary. Developing an understanding of factors that influence the choice of how youth allocate time to sedentary and active alternatives may provide insights into how obesity develops, as well as methods to prevent or treat pediatric obesity. Based on behavioral economic theory, this presentation will review experimental laboratory, field and clinical research to understand how changes in sedentary behavior can influence energy balance. Substitutability of physical activity for sedentary behavior may depend on whether sedentary behaviors are being increased or decreased. For example, nonoverweight youth are more likely to substitute physical activity for sedentary behavior than overweight youth, and the effect is bigger for boys than girls. The influence of changes in sedentary behavior on reducing energy intake may be more consistent and larger than the effects on physical activity, with significant reductions in energy intake and dietary fat intake as sedentary behaviors are reduced. The effects of incorporating reducing sedentary behavior as a component of obesity prevention and treatment studies will be presented. Individual differences in whether children substitute physical activity for sedentary behaviors or complement reductions in sedentary behavior with reductions in energy intake can predict success in pediatric obesity and prevention programs.

Biobehavioral Bases of Coronary Heart Disease Risk and Management

During the past 40 years my colleagues and I have been studying the biobehavioral bases of coronary heart disease (CHD). Some of this research has focused upon stress, sympathetic nervous system (SNS) activation and attenuation of stress responses. For example, we found that Watanabe rabbits, who normally die prematurely from CHD because of genetic defect, show significant decreases in stress responses and progression of atherosclerosis if allowed to form stable long-term relationships. For more than a decade we have also worked with the hypothesis that a positive feedback loop involving increases in SNS activity, insulin resistance and hyperinsulinemia is responsible for increasing CHD risk by promoting metabolic syndrome (MS). This syndrome includes central obesity, hyperglycemia, elevated blood pressure and dyslipidemia. We have therefore explored pathways leading to MS in adolescents, healthy adults, women with history of gestational diabetes, and post-myocardial infarction patients, and found that psychosocial variables, insulin resistance and inflammatory processes are involved. Because treatment of MS requires weight loss involving diet and exercise, treatments aimed at primary or secondary prevention of CHD that ignore these variables in high risk patients may have high failure rates.

Establishing moderators and mediators to elucidate possible causal chains is important both for social/ behavioral and biomedical research. In social/behavioral research, the approach has been based on a model originally introduced by Baron and Kenny in 1986. More recently, modifications to that approach better suited to biomedical research have been introduced by a MacArthur network subgroup. For both approaches, the conceptual definitions are the same: a moderator helps explain on whom or under what conditions a target variable produces an effect on the outcome; a mediator helps explain why or how a target variable produces that effect. However, the MacArthur approach both extends the Baron & Kenny approach and resolves its ambiguities by: (1) imposing screening criteria that uniquely identify whether a variable is eligible for consideration as a moderator or mediator; (2) imposing analytic criteria that uniquely demonstrate whether an eligible variable functions as a moderator or mediator; (3) not drawing causal inferences from observational data; and (4) systematically considering important relationships among variables beyond the roles of moderators and mediators. To assist researchers considering moderator/mediator issues in their choice of which approach is better suited to their research needs, we will present the similarities and contrasts between the two approaches using both theoretical and pragmatic examples, including the calculation of effect sizes for moderators and mediators.

Evidence for Gene-Nutrition and Gene-Physical Activity Interactions

The modulation of gene expression is influenced by a number of nuclear intrinsic affectors but also by molecules relaying messages to the nuclear DNA as a result of demands imposed on the organism, organs, tissues and ultimately cells. Among the agents that have the potential to entrain cellular responses in the form of gene expression or repression, diet, exercise, hypoxia, smoking, alcohol, drugs, cold, heat, pollutants and allergens are pervasive in our modern-day environment. Of particular relevance to us here are the interaction effects between genes and dietary factors or exercise. The central question is whether there are differences among people in the ability to adapt to defined diet or exercise conditions that are determined by DNA sequence variation or epigenetic factors. A number of family and twin studies have indicated that gene-nutrition and gene-exercise interaction effects are ubiquitous. Human experimental studies focusing on the response to standardized overfeeding, dietary fat, negative energy balance and exercise protocols have provided strong evidence for such gene-environment interaction effects. Genes and SNPs that contribute to the individuality in the response to given dietary or exercise interventions have begun to be identified. The potential implications of these observations and of epigenetic mechanisms for behavioral medicine will be discussed.

Cancer prevention priorities in populations are best addressed by interdisciplinary approaches that span disciplines and work through existing organizational structures. Liz Fries' research exemplifies the successful application of theory and methods from psychology, adapted for individuals and communities who could benefit most from prevention programs. She has conducted both laboratory and community research, testing cognitive strategies to improve health behaviors. The Rural Physician Cancer Prevention Project was a physician-endorsed, lowintensity dietary intervention that was tested in a rural, low-literacy, nonwhite population. Patients in the intervention group improved their dietary fat and fiber behavior and related factors and maintained the changes over 12 months follow-up. Another study at a rural worksite used an employee-guided intervention to improve dietary and smoking behaviors. Recent work in the Bridge to Better Health (BRIDGE) project has focused on providing rural middle school youth with motivation, knowledge, and skills needed for cancer prevention. This Memorial Lecture will review research accomplishments of Elizabeth A. Fries and highlight contributions to the larger literature in behavioral medicine and cancer prevention.

*In the Eye of the Storm: Clinical Trials versus Observational Studies*

Over the last decades, numerous observational studies have reported strong and consistent associations between social networks, depression and other social and psychological conditions and cardiovascular disease morbidity and mortality. Most of these studies have been methodologically very strong-pointing out the longitudinal course of these risk and protective factors in relation to disease development and prognosis. Recently, more evidence has accumulated suggesting the ways in which these conditions impact health across the life course. In contrast, results from several large clinical trials have shown much weaker effects for interventions related to these risks and sometimes have indicated there may be negative effects in some subpopulations. Which findings should we trust? Is it possible that both teach us important lessons? The disparities among these studies call for a deeper interpretation of the findings. In this presentation, contrasting findings among these studies will be explored and issues related to generalizabilty and internal validity will be discussed. In order to develop effective interventions, it is critical to identify where in the course of human development and disease progression social and psychological factors have their greatest impact.

As modern medicine converts many types of cancer from terminal into chronic illnesses, there is more need than ever for techniques that provide comfort, social support, and stress management skills to cancer survivors. The increased need for such approaches is evidenced by the growing public appetite for complementary treatments, now utilized by 42% of Americans who pay more out of pocket for such approaches than they do for conventional medical care. Comorbid disorders such as depression and anxiety complicate the lives of a substantial proportion of cancer patients. A growing body of evidence demonstrates that psychotherapeutic techniques such as individual and group therapy, peer navigator programs, mindfulness training, and hypnosis reduce distress, pain, and social isolation. Therapeutic domains include building new networks of social support, encouraging the expression of emotion related to the stress of illness, detoxifying fears of dying and death, restructuring life priorities, improving relationships with family and friends, clarifying communication with physicians and encouraging adherence to treatment, and stress and pain management strategies. There has been debate about the efficacy and effectiveness of such interventions. Evidence from randomized prospective outcome trials will be reviewed. Dependent variables include anxiety, PTSD, depression, coping styles, and pain. Research on physiological effects including the endocrine and immune system will also be discussed.
