

Control and Stabilization of the Benjamin-Ono Equation in $L^2(\mathbb{T})$

Abstract

We study the control and stabilization of the Benjamin-Ono equation in $L^2(\mathbb{T})$, the lowest regularity where the initial value problem is well-posed. This problem was already initiated in Linares and Rosier (Trans Am Math Soc 367:4595–4626, [2015\)](#page-43-0) where a stronger stabilization term was used (that makes the equation of parabolic type in the control zone). Here we employ a more natural stabilization term related to the L^2 –norm. Moreover, by proving a theorem of controllability in L^2 , we manage to prove the global controllability in large time. Our analysis relies strongly on the bilinear estimates proved in Molinet and Pilod (Anal PDE 5:365–395, [2012\)](#page-44-0) and some new extension of these estimates established here.

1. Introduction

In this paper, we consider the BO equation posed on the periodic domain $\mathbb{T} =$ $\mathbb{R}/(2\pi\mathbb{Z})$:

$$
u_t + \mathcal{H}u_{xx} - uu_x = 0, \quad x \in \mathbb{T}, \ t \in \mathbb{R}, \tag{1.1}
$$

where *u* is real valued and the Hilbert transform $\mathcal H$ is defined via the Fourier
transform as
 $(\widehat{\mathcal H}u)(\xi) = -i \operatorname{sgn}(\xi) \widehat{u}(\xi), \quad \xi \in \mathbb Z.$ transform as

$$
(\widehat{\mathcal{H}u})(\xi) = -i \operatorname{sgn}(\xi)\widehat{u}(\xi), \quad \xi \in \mathbb{Z}.
$$

In the periodic setting the best known result to date regarding well-posedness for the Cauchy problem was obtained by MOLINET $[34]$ $[34]$ (see also $[37]$ $[37]$), which guarantees the global well-posedness of the problem (1.1) for initial L^2 data. One of the main tools employed to obtain this result is the use of Tao's gauge transform [\[51\]](#page-44-5).

The BO equation possesses an infinite number of conserved quantities (see [\[9](#page-42-5)]). The first two conserved quantities are

$$
I_1(t) = \int_{\mathbb{T}} u(x, t) \, \mathrm{d}x
$$

and

$$
I_2(t) = \int_{\mathbb{T}} u^2(x, t) \, \mathrm{d}x.
$$

Since the BO equation was derived to study the propagation of interfaces of stratified fluids, it is natural to think of I_1 and I_2 as expressing conservation of volume (or mass) and energy, respectively.

Here we will study the Equation (1.1) from a control point of view with a forcing term $f = f(x, t)$ added to the equation as a control input:

$$
u_t + \mathcal{H}u_{xx} - uu_x = f(x, t), \quad x \in \mathbb{T}, \ t \in \mathbb{R}, \tag{1.2}
$$

where *f* is assumed to be supported in a given open set $\omega \subset \mathbb{T}$. In control theory the following problems are essential:

Exact Control Problem: Given an initial state u_0 and a terminal state u_1 in a certain space, can one find an appropriate control input f so that the Equation (1.2) admits a solution *u* which satisfies $u(\cdot, 0) = u_0$ and $u(\cdot, T) = u_1$?

Stabilization Problem: Can one find a feedback law $f = Ku$ so that the resulting closed-loop system

$$
u_t + \mathcal{H}u_{xx} - uu_x = Ku, \quad x \in \mathbb{T}, \ t \in \mathbb{R}^+
$$

is asymptotically stable as $t \rightarrow +\infty$?

Those questions were first investigated by RUSSELL AND ZHANG in [\[49\]](#page-44-6) for the Korteweg-de Vries equation, which serves as a model for propagation of surface waves along a channel:

$$
u_t + u_{xxx} - uu_x = f, \quad x \in \mathbb{T}, \ t \in \mathbb{R}.
$$
 (1.3)

In their work, in order to keep the *mass* $I_1(t)$ conserved, the control input was chosen in the form <u>and the second contract of the second</u>

$$
f(x,t) = (\mathcal{G}h)(x,t) := a(x) \left(h(x,t) - \int_{\mathbb{T}} a(y)h(y,t) \, dy \right) \tag{1.4}
$$

where *h* is considered as a new control input, and *a*(*x*) is a given nonnegative
smooth function such that $\{x \in \mathbb{T}; a(x) > 0\} = \omega$ and
 $2\pi[a] = \int_{\mathbb{T}} a(x) dx = 1$. smooth function such that ${x \in \mathbb{T}$; $a(x) > 0} = \omega$ and

$$
2\pi[a] = \int_{\mathbb{T}} a(x) \, \mathrm{d}x = 1.
$$

For the chosen *a*, it is easy to see that

$$
\frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{T}} u(x, t) \, \mathrm{d}x = \int_{\mathbb{T}} f(x, t) \mathrm{d}x = 0 \quad \forall t \in \mathbb{R}
$$

for any solution $u = u(x, t)$ of the system

$$
u_t + u_{xxx} - uu_x = \mathcal{G}h, \quad x \in \mathbb{T}, \ t \in \mathbb{R}.
$$
 (1.5)

Thus the *mass* of the system is indeed conserved.

The control of dispersive nonlinear wave equations on a periodic domain has been extensively studied in the last decade: see example [\[28](#page-43-9),[46,](#page-44-7)[49\]](#page-44-6) for the Kortewegde Vries equation, [\[33](#page-43-10)] for the Boussinesq system, [\[48](#page-44-8)] for the Benjamin-Bona-Mahony equation, and [\[12,](#page-43-11)[26,](#page-43-12)[27](#page-43-13)[,44](#page-44-9)[,47](#page-44-10)] for the nonlinear Schrödinger equation. By contrast, the control theory of the BO equation is at its early stage. The linear problem was studied by Linares and Ortega [\[29](#page-43-14)]. They established the following results regarding control and stabilization in this case.

Theorem A. ([\[29\]](#page-43-14)) *Let* $s \ge 0$ *and* $T > 0$ *be given. Then for any* $u_0, u_1 \in H^s(\mathbb{T})$ *with* $[u_0] = [u_1]$ *one can find a control input h* $\in L^2(0, T, H^s(\mathbb{T}))$ *such that the solution of the system*

$$
u_t + \mathcal{H}u_{xx} = \mathcal{G}h, \qquad u(x,0) = u_0(x) \tag{1.6}
$$

satisfies $u(x, T) = u_1(x)$.

In order to stabilize (1.6) , they employed a simple control law

$$
h(x, t) = -\mathcal{G}^* u(x, t) = -\mathcal{G} u(x, t).
$$

The resulting closed-loop system reads

$$
u_t + \mathfrak{H} u_{xx} = -\mathfrak{G} \mathfrak{G}^* u.
$$

Theorem B. ([\[29](#page-43-14)]) *Let* $s \ge 0$ *be given. Then there exist some constants* $C > 0$ *and* $\lambda > 0$ *such that for any* $u_0 \in H^s(\mathbb{T})$ *, the solution of*

$$
u_t + \mathcal{H} u_{xx} = -\mathcal{G} \mathcal{G}^* u, \quad u(x, 0) = u_0(x),
$$

satisfies

$$
||u(\cdot,t)-[u_0]||_{H^s(\mathbb{T})}\leq Ce^{-\lambda t}||u_0-[u_0]||_{H^s(\mathbb{T})} \quad \forall t\geq 0.
$$

One of the main difficulties of extending the linear results to the nonlinear ones comes from the fact that one cannot use the contraction principle in its usual form to establish the local well-posedness of BO in $H_0^s(\mathbb{T}) = \{u \in H^s(\mathbb{T}), \ [u] = 0\}$ for $s \ge 0$ (see [\[39\]](#page-44-11)). The method of proof in [\[34](#page-43-8),[37\]](#page-44-0) strongly used Tao's gauge transform, and it is not clear whether this approach can be followed when an additional control term is present in the equation. Nevertheless, Linares and Rosier in [\[31](#page-43-0)] obtained the first results regarding stabilization and control for the BO equation. For completeness we will briefly describe these results.

Actually, it is easily seen that G is self-adjoint (that is $\mathcal{G}^* = \mathcal{G}$). However, we shall keep the usual notation for the feedback $h = -\mathcal{G}^*u$ throughout.

In [\[31](#page-43-0)] was considered the following feedback law

$$
h = -D(\mathcal{G}u),
$$

In [31] was considered the following feedback law
 $h = -D(\mathcal{G}u)$,

where $\widehat{Du}(\xi) = |\xi| \widehat{u}(\xi)$ is used to stabilize the BO equation. Thus scaling in [\(1.3\)](#page-1-1) by *u* gives (at least formally) ed to s t

$$
\frac{1}{2}||u(T)||_{L^{2}(\mathbb{T})}^{2} + \int_{0}^{T} \left\| D^{\frac{1}{2}}(\mathcal{G}u) \right\|_{L^{2}(\mathbb{T})}^{2} dt = \frac{1}{2} ||u_{0}||_{L^{2}(\mathbb{T})}^{2}, \qquad (1.7)
$$

which suggests that the energy is dissipated over time. On the other hand, (1.7) reveals a smoothing effect, at least in the region {*a* > 0}. Using a *propagation of regularity property* in the same vein as in [\[12](#page-43-11),[26](#page-43-12)[–28\]](#page-43-9), it was proved that the smoothing effect holds everywhere, that is

$$
||u||_{L^{2}\left(0,T;H^{\frac{1}{2}}(\mathbb{T})\right)} \leq C(T, ||u_0||). \tag{1.8}
$$

Using this smoothing effect and the classical compactness/uniqueness argument, it was shown that the corresponding closed-loop equation is semi-globally exponentially stable. More precisely,

Theorem C. ([\[31\]](#page-43-0)) Let $R > 0$ be given. Then there exist some constants $C = C(R)$ *and* $\lambda = \lambda(R)$ *such that for any* $u_0 \in H_0^0(\mathbb{T})$ *with* $\|u_0\| \leq R$ *, the weak solutions in the sense of vanishing viscosity of*

$$
u_t + \mathcal{H}u_{xx} - uu_x = -\mathcal{G}(D(\mathcal{G}u)), \quad u(x,0) = u_0(x), \tag{1.9}
$$

satisfy

$$
||u(t)|| \leq Ce^{-\lambda t}||u_0|| \quad \forall t \geq 0.
$$

Using again the smoothing effect (1.8) , it was possible to extend (at least locally) the exponential stability from $H_0^0(\mathbb{T})$ to $H_0^s(\mathbb{T})$ for $s > 1/2$.

Theorem D. ([\[31\]](#page-43-0)) *Let* $s \in (\frac{1}{2}, 2]$ *. Then there exists* $\rho > 0$ *such that for any data* $u_0 \in H_0^s(\mathbb{T})$ *with* $||u_0||_{H^s(\mathbb{T})} \leq \rho$, there exists for all $T > 0$ a unique solution $u(t)$ *of* [\(1.9\)](#page-3-2) *in the class* $C([0, T], H_0^s(\mathbb{T})) \cap L^2(0, T, H_0^{s+\frac{1}{2}}(\mathbb{T}))$ *. Furthermore, there exist some constants* $C > 0$ *and* $\lambda > 0$ *such that*

$$
||u(t)||_s \leq Ce^{-\lambda t}||u_0||_s \quad \forall t \geq 0.
$$

Finally, including the same feedback law $h = -D(\mathcal{G}u)$ in the control input to obtain a smoothing effect, an exact controllability result for the full equation was derived as well. More precisely,

Theorem E. ([\[31](#page-43-0)]) *Let* $s \in (\frac{1}{2}, 2]$ *and* $T > 0$ *be given. Then there exists* $\delta > 0$ *such that for any* $u_0, u_1 \in H_0^s(\mathbb{T})$ *satisfying*

$$
||u_0||_{H^s(\mathbb{T})} \leq \delta, \quad ||u_1||_{H^s(\mathbb{T})} \leq \delta
$$

one can find a control input $h \in L^2(0, T, H^{s-\frac{1}{2}}(\mathbb{T}))$ *<i>such that the system* [\(1.5\)](#page-2-2) $admits a solution u \in C([0, T], H_0^s(\mathbb{T})) \cap L^2(0, T, H_0^{s+\frac{1}{2}}(\mathbb{T}))$ *satisfying*

$$
u(x, 0) = u_0(x), \quad u(x, T) = u_1(x).
$$

Our main purpose here is to obtain the control and stabilization result in the largest space where local well-posedness is known for the BO equation, that is, for initial data in $L^2(\mathbb{T})$. As we commented above the main difficulty in treating the problem for data in L^2 is using the gauge transform $w = -\frac{i}{2}P_+(ue^{-\frac{i}{2}F})$ introduced in [\[51](#page-44-5)]. We first consider the Cauchy problem associated to the BO equation with a forcing term, that is,

$$
\begin{cases} u_t + \mathfrak{H}u_{xx} - uu_x = g, & x \in \mathbb{T}, \ t > 0, \\ u(x, 0) = u_0(x) \end{cases}
$$
 (1.10)

for data in $L^2(\mathbb{T})$ and $g \in L^2([0, T], L^2(\mathbb{T}))$. Then, we establish the well-posedness theory for (1.10) . The main tool used is the bilinear estimates approach employed by MOLINET AND PILOD [\[37\]](#page-44-0) to show the local well-posedness of the BO equation in both cases in the real line and in the periodic setting for data in $L^2(\mathbb{T})$ (see [\[18](#page-43-3)] for the first proof of this result in $L^2(\mathbb{R})$). The argument in [\[37](#page-44-0)] takes advantage of uniform estimates for small data for which the gauge transform is well defined and a scaled argument (subcritical) is used to consider any size data. In our case, we apply some Sobolev estimates which avoid the use of uniform estimates and we apply directly the argument in [\[37\]](#page-44-0). Then we have to analyze the gauge transform for large frequency data, for which this transformation has a bad behavior. To do so we extend previous estimates to overcome this difficulty. For instance we refine the bilinear estimates and obtain an extra time factor (see Lemma [2.8\)](#page-12-0) as well as intermediate estimates to deal with large data (see the "Appendix").

Next we describe the main results in this paper.

We begin with the exact controllability result, more precisely:

Theorem 1.1. (i) (*Small data*) *For any* $T > 0$ *, there exists some* $\delta > 0$ *such that for any* $u_0, u_1 \in L^2(\mathbb{T})$ *with*

 $||u_0|| \leq \delta$, $||u_1|| \leq \delta$ *and* $[u_0] = [u_1]$

one can find a control input h $\in L^2([0, T], L^2(\mathbb{T}))$ *such that the solution u of the system*

$$
\begin{cases} u_t + \mathcal{H}u_{xx} - uu_x = \mathcal{G}h, \\ u(x, 0) = u_0(x) \end{cases}
$$
 (1.11)

satisfies $u(x, T) = u_1(x)$ *on* \mathbb{T} *.*

(ii) (*Large data*) *For any* $R > 0$ *, there exists a positive* $T = T(R)$ *such that the above property holds for any* $u_0, u_1 \in L^2(\mathbb{T})$ *with*

$$
||u_0|| \leq R
$$
, $||u_1|| \leq R$ and $[u_0] = [u_1]$.

Remark 1.1. We will give the proof of the theorem assuming that $[u_0]=[u_1]=$ $||u_0|| \le R$, $||u_1|| \le R$ and $|u_0| = |u_1|$.

0. The general case can be done after the change of variables \tilde{u} **u**(*x*) = u_0 = u_1 = u_2 = u_3 + u_4 = u_5 + u_6 + u_7 + u_8 + u_9 + u_9 + u_1 = u_2 + u_3 + u_4 + u_5 + u_7 + u_8 + u_9 + u $t[u_0]$, t) − [u_0] is made in the equation in [\(1.11\)](#page-4-1). The results in Theorem A remain valid for the new equation in \tilde{u} .

The argument of proof is as follows. The control result for large data (ii) will be a combination of a stabilization result presented below and of the result (i) for small data, as is usual in control theory (see for instance [\[12](#page-43-11),[13,](#page-43-15)[26](#page-43-12)[–28\]](#page-43-9)). The local control result (i) will be proved using a perturbation argument from the linear result [\[29\]](#page-43-14). The difficulty comes from the fact that we need some estimates at higher order for the nonlinear equation, which are quite complicated due to the absence of a direct Duhamel formulation. Indeed, we need to have an expansion for all the elements used for the well-posedness theory. These estimates will come from the Benjamin-Ono equation verified by *u*, from the equation verified by the gauge transform w and from the "inversion" of the gauge transform. For example, we will need some estimates of the form $2iw = P_+u + o(||(u, v)||_X^2)$ and some Lipschitz type estimates of this fact.

In order to stabilize (1.11) , we employ a simple control law

$$
h(x,t) = -\mathcal{G}^*u(x,t),
$$

where \mathcal{G}^* denotes the adjoint operator of \mathcal{G} . Thus the resulting closed-loop system is

$$
u_t + \mathfrak{H} u_{xx} + u u_x = -\mathfrak{G} \mathfrak{F}^* u.
$$

Theorem 1.2. *There exist some functions c*, $\lambda : \mathbb{R}_+ \to \mathbb{R}_+$ *with c nondecreasing and* λ *nonincreasing such that for any* $u_0 \in L^2(\mathbb{T})$ *, the solution of*

$$
\begin{cases} u_t + \mathcal{H}u_{xx} - uu_x = -\mathcal{G}\mathcal{G}^*u, \\ u(x, 0) = u_0(x) \end{cases}
$$
 (1.12)

satisfies

$$
||u(\cdot, t) - [u_0]||_{L^2(\mathbb{T})} \leq Ce^{-\lambda t} ||u_0 - [u_0]||_{L^2(\mathbb{T})} \quad \forall t \geq 0
$$

 $where \lambda = \lambda(||u_0||), C = C(||u_0||).$

where $\lambda = \lambda(||u_0||)$, $C = C(||u_0||)$.

 Remark 1.2. After the change of variables $\tilde{u}(x, t) = u(x - t[u_0], t) - [u_0]$ described in Remark [1.1,](#page-4-2) we are left with some solutions with $[\tilde{u}] = 0$ and with the same equation but with G replaced by \mathcal{G}_{μ} defined by

$$
\left(\mathcal{G}_{\mu}h\right)(x,t) := a(x - \mu t) \left(h(x - \mu t, t) - \int_{\mathbb{T}} a(y)h(y, t) \, \mathrm{d}y \right) \tag{1.13}

with $\mu = [u_0]$.

We will give the proof of the theorem assuming that $\mu = [u_0] = 0$ and detail in some remarks the necessary modifications when G is replaced by \mathcal{G}_{μ} .

The proof of the stabilization theorem will be obtained by an observability estimate proved by the compactness-uniqueness method. The difference from the case of the nonlinear Schrödinger equation (see for instance [\[12,](#page-43-11)[26](#page-43-12)[,27\]](#page-43-13)) or other nonlinear conservative equations $([13, 28, 42, 43])$ $([13, 28, 42, 43])$ $([13, 28, 42, 43])$ $([13, 28, 42, 43])$ $([13, 28, 42, 43])$ $([13, 28, 42, 43])$ $([13, 28, 42, 43])$ comes again from the use of the gauge transform. We need to propagate some information from the zone of damping to the whole space, yet the absence of a Duhamel formulation prevents us from doing that directly on the solution *u*. The idea is to transfer this information from

the solution u to the gauge transform w , then to apply some propagation results to w , and finally to obtain the expected result by returning to the original solution u .

As was already mentioned, one of the main ingredients in our analysis is the study of the well-posedness of the IVP

$$
\begin{cases} u_t + \mathcal{H}u_{xx} - uu_x = g, & x \in \mathbb{T}, \ t > 0, \\ u(x, 0) = u_0(x), \end{cases}
$$
 (1.14)

for data $u_0 \in L^2(\mathbb{T})$ and where $g \in L^2([0, T], L^2(\mathbb{T}))$. More precisely,

Theorem 1.3. *For any* $u_0 \in L^2(\mathbb{T})$, $g \in L^2([0, T], L^2(\mathbb{T}))$ *and* $T > 0$ *, there exists a solution*

$$
u \in C([0, T], L^{2}(\mathbb{T})) \cap X_{T}^{-1, 1} \cap L^{4}_{T}L^{4}(\mathbb{T})
$$
\n(1.15)

of [\(1.14\)](#page-6-0) *such that*

$$
w = \partial_x P_+ \left(e^{-\frac{i}{2}\partial_x^{-1}\tilde{u}} \right) \in X_2 \tag{1.16}
$$

where

$$
\tilde{u} = u(x - t[u_0], t) - [u_0]
$$
 and $\widehat{\partial_x^{-1}} := \frac{1}{i\xi}, \xi \in \mathbb{Z}^*,$

and $X_T^{-1,1}$ and X_2 are defined in [\(2.3\)](#page-7-0) and [\(2.5\)](#page-8-0) below, respectively.

The solution u is unique in the class

$$
u \in L^{\infty}((0, T); L^{2}(\mathbb{T})) \cap L^{4}((0, T) \times \mathbb{T})
$$
 and $w \in X_T^{0, 1/2}$,

where $X_T^{0,1/2}$ is defined in (2.3) below.

Moreover, $u \in C([0, T]; L^2(\mathbb{T}))$ *and the flow map data–solution:* $(u_0, g) \to u$ *is locally Lipschitz continuous from L*²(\mathbb{T}) *into C*([0, *T*]; *L*²(\mathbb{T})).

The proof of this theorem does not follow directly from the theory established by MOLINET AND PILOD [\[37](#page-44-0)]. We have to distinguish two cases, small and large data, instead. To apply the scale argument in [\[37\]](#page-44-0) there is a need of some uniform estimates that do not hold when we introduce the source term *g* and consider any data. To deal with large data we have to go around the gauge transform since in this case it is not "invertible". We prove the theorem when $[u_0] = 0$. The general case follows as commented above.

The plan of the paper is as follows: in Section [2](#page-7-1) we introduce some notations and establish estimates needed in our analysis. General estimates which do not depend on the size of the data are derived in Section [3.](#page-12-1) In Section [4](#page-20-0) we deduce estimates used to complete the proof of Theorem [1.3](#page-6-1) for small data. Next, in Section [5,](#page-22-0) we establish Theorem [1.3](#page-6-1) for large data. The control results are proved in Section [6.](#page-29-0) Section [7](#page-31-0) contains preliminary tools to establish Theorem [1.2.](#page-5-0) The stabilization is demonstrated in Section [8,](#page-37-0) and finally we include an appendix containing some technical results.

2. Notations and Preliminary Estimates

We use standard notation in Partial Differential Equations. In addition, we will use *C* to denote various constants that may change from line to line. For any positive numbers *a* and *b*, we use the notation $a \lesssim b$ to mean that there exists a constant *C* and there $a \leq C b$ such that $a \leq C b$.

For a 2π -periodic function *f* we define its Fourier transform on \mathbb{Z} by

$$

Remark [2.1](#page-8-3). We observe that the estimates in Lemmas 2.1[–2.4](#page-9-1) also hold for solution of the IVP (2.19) .

We will end this section giving the statement of the key (main) bilinear estimate we will use in our analysis. It was proved by Molinet and Pilod (see Proposition 3.5 of [\[37\]](#page-44-0)).

We shall remark that this estimate is a slight modification of the estimates in [\[37](#page-44-0)] since we also have a factor T^{θ} that will be very useful in making some bootstrap and absorption arguments. In the appendix, we sketch the modification of proof of MOLINET-PILOD [\[37](#page-44-0)] that allows us to obtain that term.

In what follows, we will fix $\theta \in (0, 1/8)$ such that Lemma [2.8](#page-12-0) and [\(2.11\)](#page-9-2) hold for $0 < T \leq 1$.

3. General Estimates

In this section we will derive estimates needed in our argument which are independent of the size of the initial data.

4. Small Data Estimates

The control results as well as the proof of Theorem [1.3](#page-6-1) depend on the size data. In this section we aim to establish all the estimates related to small data needed in our arguments. We will also give the proof of Theorem [1.3](#page-6-1) corresponding to small data.

Since we are just considering real valued functions we have $P_-u = \overline{P_+u}$, thus

5. Large Data Estimates

In this section we will complete the proof of Theorem [1.3](#page-6-1) and establish some estimates for large data useful for further analysis.

5.1. Low-Frequency Estimate

In this subsection, we establish some estimates of the low frequency component of the solution for eventually large data. These estimates are necessary because the gauge transform is not invertible at low frequency for large data.

Let $N \in \mathbb{N}^*$ be fixed. We will prove some estimates that might depend on N.

5.1.1. Global large data estimates We change a little the decomposition [\(3.19\)](#page-17-2). The point is, roughly speaking, to make the gauge transform "invertible" at high frequency (the frequency will depend on the size of the data). For large *F* the second term of the gauge transform [\(3.19\)](#page-17-2) is bad, and the gauge transform cannot be inverted for large *F*, but in some sense, it can be inverted at large positive frequencies. Note that another way of obtaining global estimates for large data used by MOLINET $[34]$ was to use the scaling argument to get to some small data (because the equation is subcritical). However this approach requires us to have some estimates uniform on the lengths of the interval. Many of the estimates we used are indeed uniform, but this is not the case for the Sobolev embedding $H^1 \hookrightarrow L^{\infty}$. We recall that we use the Sobolev spaces H^s_λ for a $(2\pi\lambda)$ –periodic function defined by α bedding

One **solution** found by MOLINET in [\[34\]](#page-43-8) was to apply this estimate to P_1 and the estimate indeed becomes uniform. Our approach is much in the same spirit however we believe that it gives another point of view and may be more reliable in the case of a damped equation or source term.

With this estimate at hand we proceed to establish a uniform Lipschitz bound for large data.

We can now use a bootstrap argument (see for instance Lemma 2.2 of [\[5](#page-42-7)]) using Lemma [2.7](#page-10-1) for the continuity and limit in zero. Let $R > 0$ such that $||u_0||_{L^2}$ + $\|g\|_{L^2([0,T],L^2)} \leq R$. We first pick *N* large enough and then *T* small enough (only depending on *R* and universal constants) to get by a boot strap

6. Control Results

In this section we will prove Theorem [1.1.](#page-4-3) First we will consider the damped equation and apply the theory established in the previous section to this case.

6.1. Damped Equation

We consider the equation

$$
\begin{cases} \partial_t u + \mathcal{H} \partial_x^2 u = \frac{1}{2} \partial_x (u^2) - \mathcal{G} \mathcal{G}^* u \\ u(T) = 0. \end{cases}
$$
 (6.1)

Setting $g = -\frac{G}{g*}u$ in [\(2.15\)](#page-10-0) we can see the damping term as a source term. Thus, we have

$$
\|g\|_{L^2([0,T],L^2)} \leqq C T^{1/2} \|u\|_{L^\infty([0,T],L^2)} \leqq C T^{1/2} \|u,w\|_X.

Hence, the estimate (5.11) becomes

We can conclude similarly by a bootstrap for small times (only depending on the size). This gives the expected result for small times. For large times, we use the energy estimate (for *t* positive or negative)

Now we proceed to prove Theorem [1.1.](#page-4-3) We want to control the following problem

where \hat{S} is defined as in [\(1.4\)](#page-1-2).

We seek control of the form of a solution of (h_0) is real valued with zero mean)

We denote by B the nonlinear operator defined by $Bh_0 = u(0)$. Let u_L be the solution of

The linear operator from $L^2(\mathbb{T})$ to itself defined by $Lh_0 = u_L(0)$ is the HUM operator (see [\[32](#page-43-19)]), which is a bijection of $L^2(\mathbb{T})$ by the observability inequality of LINARES-ORTEGA [\[29\]](#page-43-14). We note that $Wh_0 = u(0) = u_L(0) + Kh_0 = Lh_0 + Kh_0$, and that (4.2) can be written as

$$
||Kh_0||_{L^2} \leqq C||h_0||_{L^2}^2
$$

for $||h_0||_{L^2}$ small enough. Let $u_0 \in L^2(\mathbb{T})$. So, the objective $Wh_0 = Lh_0 + Kh_0 =$ *u*₀ is equivalent to $h_0 = -L^{-1}Kh_0 + L^{-1}u_0$, that is h_0 is a fixed point of *B* defined by $Bh_0 = -L^{-1}Kh_0 + L^{-1}u_0$.

However, we have

||Bh_0||_{L^2} \leqq C||Kh_0||_{L^2} + C||u_0||_{L^2} \leqq C||h_0||_{L^2}^2 + C||u_0||_{L^2}.
$$

Thus, if we denote B_R the unit ball of L^2 of radius $R = 2C||u_0||_{L^2}$, B sends B_R into itself if $CR \leq 1/2$, that is, if $||u_0||_{L^2}$ is chosen small enough.

Moreover, estimate [\(4.4\)](#page-21-1) shows that for two solutions of the nonhomogeneous problem u_1, u_2 coming from the controls $g_i = -\mathcal{G} \mathcal{G}^* h_i$ (recall that we have assumed $||g_i||_{L^2([0,T]\times\mathbb{T})} \leq \varepsilon$, which is equivalent to $||h_{0,i}||_{L^2} \leq \varepsilon$, we have the estimates

$$
||Kh_{0,1} - Kh_{0,1}||_{L^2} \le ||u_1 - u_{L,1} - (u_2 - u_{L,2})||_{L^{\infty}([0,T],L^2)}
$$

\$\lesssim \varepsilon ||g_1 - g_2||_{L^2([0,T] \times \mathbb{T})}.

Since $Bh_{0,1}-Bh_{0,2}=Kh_{0,1}-Kh_{0,2}$, this means that for ε small enough (that is $R = 2C \Vert u_0 \Vert_{L^2}$ small enough), *B* is contracting and reproduces B_R . Therefore, it has a fixed point which is the expected control.

This ends the proof of Theorem [1.1](#page-4-3) part (i) for small data.

7. Study of the Convergence of Some Bounded Sequences of Solutions of the Damped Equations

The aim of this section is to show the convergence of some bounded sequences ${u_n}$ of solutions to the damped equation such that $\mathcal{G}u_n$ converges to zero. The results here will be used to perform a contradiction argument which allows us to establish the stabilization theory claimed in Theorem [1.2.](#page-5-0) As we commented before we have to distinguish two cases: large and small data.

7.1. Large Data

We consider a sequence of solutions $\{u_n\}$ of the damped equation

$$
\partial_t u_n + \mathfrak{H} \partial_x^2 u_n = u_n \partial_x u_n (-\mathfrak{G} \mathfrak{G}^* u_n)
$$

$$
u_n(0) = u_{0,n}.
$$

We first suppose that (u_n, w_n) is bounded in *X*. We then show that $u_n \rightharpoonup 0$ in $L^2([0, T], L^2)$ and weakly-* in $L^\infty([0, T], L^2)$ (see Lemma [7.1](#page-31-1) below). Finally we will prove strong convergence in L^2 (see Theorem [7.2](#page-35-0) below). One of the main ingredients to obtain the latter result is the propagation compactness theory in [\[26](#page-43-12)]. We assume $[u_0] = 0$ to make the proofs more clear but at the end of each proof we will explain in a remark the required modifications for the general case. Lemma 7.1. *Suppose* $u_{n,0}$ *is a bounded sequence in* L^2 *with* $[u_{0,n}] = 0$ *with associated solutions un*

\partial_t u_n + \mathfrak{H} \partial_x^2 u_n = u_n \partial_x u_n \left(-\mathfrak{G} \mathfrak{G}^* u_n \right)
$$

$$

Assume moreover that $\mathcal{G}u_n \to 0$ *in* $L^2([0, T] \times \mathbb{T})$ *. Then,* $u_n \to 0$ *in* $L^2([0, T], L^2)$ *and weakly-* in* $L^{\infty}([0, T], L^2)$.

Remark 7.1. We could certainly get rid of the term $\mathcal{G}\mathcal{G}^*u_n$ (converging to 0 in $L^2([0, T] \times L^2)$ and work with solutions of the free equation, yet we have chosen to keep it since it does not greatly change the analysis and it seems easier than proving a general perturbation theorem.

Proof. We assume $u_n \rightharpoonup u$ in $L^2([0, T], L^2)$ up to subsequence. The only problem in using directly Proposition 2.8 of [\[31\]](#page-43-0) is that, because of the nonlinear term, it is
not clear that *u* is a solution of the Benjamin-Ono equation (see MOLINET [35,36]
for some cases where the limit equation is a modif not clear that u is a solution of the Benjamin-Ono equation (see MOLINET $[35,36]$ $[35,36]$ for some cases where the limit equation is a modified equation).

Denote the sequence $c_n(t) = \int_{\mathbb{T}} a(y)u_n(x, t)dy$, bounded in $L^2([0, T])$ and weakly convergent to $c(t)$. Denote $r_n = u_n - c_n$. We have $a(x)[r_n] \to 0$, in $L^2([0, T] \times \mathbb{T})$. In particular, $r_n \to 0$ in $L^2([0, T] \times \omega)$ and $r_n^2 \to 0$ in $L^1([0, T] \times \mathbb{T})$

ω). Therefore, $r_n^2 \rightharpoonup 0$ in the distributional sense of $D'(0, T[\times \omega)$ and hence it is the same for $\partial_x r_n^2$. However, we have

\partial_x r_n^2 = \partial_x u_n^2 - 2\partial_x (c_n u_n) + \partial_x c_n^2 = \partial_x u_n^2 - 2\partial_x (c_n u_n)

So, we have $r_n \to 0$ in $L^2([0, T] \times \omega)$ so $c_n r_n \to 0$ in $L^1([0, T] \times \omega)$ and so in the distributional sense in *D*[']($]0, T[\times \omega)$, and the same for $\partial_x (c_n r_n)$.

Thus, we conclude that $\partial_x u_n^2 \rightharpoonup 0$ in the distributional sense of *D'*($]0, T[\times \omega)$. In particular, the weak limit *u* is a solution in the sense of distribution $D'(0, T[x\omega)$ of

$$
u_t + \mathfrak{H} u_{xx} = \dot{c}(t) + \mathfrak{H} u_{xx} = 0.
$$

Therefore, we have $\mathcal{H}u_{xxx} = 0$ in the distributional sense of $D'(0, T[x\omega))$.

Moreover, since r_n converges to zero in the distributional sense of $D'(0, T[x\omega)$, it is the same for $r_{n,xxx} = u_{n,xxx}$ and we have $u_{xxx} = 0$ in the distributional sense of $D'(]0, T[\times \omega)$.

We conclude that $u \equiv 0$ as in LINARES-ROSIER [\[31](#page-43-0)] Proposition 2.8. \Box

Remark 7.2. In the case of $[u_{0,n}] = \mu \neq 0$, we can, for instance, set $\underline{u}_n = u_n - \mu$ and obtain, similarly, $u_n \rightharpoonup \mu$, using that \underline{u}_n is a solution of $\partial_t \underline{u}_n + \mathcal{H} \partial_x^2 \underline{u}_n =$ $\mu \partial_x u_n + u_n \partial_x u_n - \mathcal{G} \mathcal{G}^* u_n$.

Lemma 7.2. $u_n \rightharpoonup 0$ *in* $L^2([0, T], L^2)$ *implies* $w_n \rightharpoonup 0$ *in* $L^2([0, T], L^2)$ *with* $w_n = P_+(u_n e^{-\frac{i}{2}F_n})$ (for solutions). The same holds for $u_n e^{-\frac{i}{2}F_n}$.

F_n weakly-* converges to 0 in $L^\infty([0, T], H^1)$ and $\partial_t F_n$ is bounded in $L^{\infty}([0, T], H^{-1})$ and hence by Aubin-Lions lemma, F_n converges strongly to 0 in $L^{\infty}([0, T], L^{\infty})$. By the mean value theorem, $e^{-\frac{i}{2}F_n}$ converges strongly to 1 in *L*∞([0, *T*], *L*∞). Actually, $\partial_t F_n = -\mathcal{H} \partial_x^2 F_n + \frac{1}{2} (\partial_x F_n)^2 - \frac{1}{2} P_0(F_{n,x}^2) + \partial_x^{-1} \mathcal{G} \mathcal{G}^* u_n$ is bounded in $L^{\infty}([0, T], H^{-1})$ since $\partial_x^2 F_n = \partial_x u_n$ and $(\partial_x F_n)^2 = u_n^2$ is bounded in *L*[∞]([0, *T*], *L*¹) ⊂ *L*[∞]([0, *T*], *H*^{−1}).
Let $\varphi \in L^2([0, T], L^2)$. We write

 $\text{So } ||c_n(t)||_{L^2([0,T])} \leq C ||u_n||_{L^2([0,T],L^2)} + C ||u_n||_{L^\infty([0,T],L^2)}^2 \leq C.$ Lemma [7.3](#page-32-0) follows by Sobolev embedding and weak convergence to 0 of u_n .

Remark [7.3](#page-32-0). For Lemmas [7.2](#page-32-1) and 7.3 the same argument applies with $\mathcal G$ replaced by \mathcal{G}_{μ} since we only use the boundedness as an operator of $L^{\infty}([0, T], L^2)$.

Lemma 7.4. $\mathcal{G}u_n \to 0$ *in* $L^2([0, T] \times \mathbb{T})$ *implies that* $a(x)w_n \to 0$ *in* $L^2([0, T] \times \mathbb{T})$ T)*.*

Proof. Lemma [7.3](#page-32-0) implies that we have in fact $a(x)u_n \to 0$ in $L^2([0, T] \times \mathbb{T})$. Hence $a(x)e^{-\frac{i}{2}F_n}u_n \to 0$ in $L^2([0, T] \times \mathbb{T})$. Similarly, $P_+(a(x)e^{-\frac{i}{2}F_n}u_n) \to 0$ in $L^2([0, T] \times \mathbb{T}).$

We write

$$
a(x)w_n = a(x)P_+\left(u_ne^{-\frac{i}{2}F_n}\right) = P_+\left(a(x)u_ne^{-\frac{i}{2}F_n}\right) + [a(x), P_+] \left(u_ne^{-\frac{i}{2}F_n}\right).
$$

Thus, it remains to prove that the second term in the right hand side is strongly convergent in $L^2([0, T] \times \mathbb{T})$ convergent in $L^2([0, T] \times \mathbb{T})$.

From Lemma 2.5 of Linares-Rosier [\[31](#page-43-0)], we get

$$
\left\|[a(x), P_+\] \left(u_n e^{-\frac{i}{2}F_n}\right)\right\|_{L^2([0,T]\times\mathbb{T})} \leq \|u_n e^{-\frac{i}{2}F_n}\|_{L^2([0,T],H^{-1})}.
$$

Using Lemma [7.2,](#page-32-1) we get that $u_n e^{-\frac{i}{2}F_n} \rightharpoonup 0$ in $L^2([0, T] \times \mathbb{T})$. To apply Aubin-Lions' lemma, we just need to prove that $\partial_t (u_n e^{-\frac{i}{2}F_n})$ is bounded in some space $L^p([0, T], H^{-s})$, $s \in \mathbb{R}$. We also notice that $u_n e^{-\frac{i}{2}F_n} = 2i \partial_x e^{-\frac{i}{2}F_n}$, so, we just have to prove that $\partial_t e^{-\frac{i}{2}F_n} = -\frac{i}{2}(\partial_t F_n)e^{-\frac{i}{2}F_n}$ is bounded in some $L^p([0, T], H^{-s})$. However, we have shown in the proof of Lemma [7.2](#page-32-1) that $\partial_t F_n$ was bounded in $L^{\infty}([0, T], H^{-1})$ and we notice easily that $e^{-\frac{i}{2}F_n}$ is bounded in *L*[∞]([0, *T*], *H*¹), since $\partial_x e^{-\frac{i}{2}F_n} = -\frac{i}{2}u_ne^{-\frac{i}{2}F_n}$ is bounded in *L*[∞]([0, *T*], *L*²). Thus $\partial_t e^{-\frac{i}{2}F_n}$ is bounded in $L^\infty([0, T], H^{-1})$. □

Remark [7.4](#page-33-0). Lemma 7.4 has to be modified when G is replaced by \mathcal{G}_{μ} . Indeed, in that case, the damping zone is moving at speed μ , but, we can use the infinite speed of propagation to get a similar result as follows.

If $\mathcal{G}_{\mu}\tilde{u}_n \to 0$ in $L^2([0, T] \times \mathbb{T})$, we infer as before that *a*(*x* − *t*μ) $\tilde{u}_n \to 0$ in
 $L^2([0, T] \times \mathbb{T})$. If, for instance, [−*c*, $L^2([0, T] \times \mathbb{T})$. If, for instance, $[-c, c] \subset \omega$ with $c > 0$, we easily conclude that *u* there exists an ε (a priori depending on μ) such that $\tilde{u}_n \to 0$ in $L^2([0, \varepsilon] \times [-\varepsilon, \varepsilon])$.

This result will be enough for what follows since the time $T > 0$ and the open set ω are arbitrary (ω non empty).

Now, we borrow a propagation theorem from [\[26](#page-43-12)].

Theorem 7.1. *Let* w*ⁿ be a sequence of solutions of*

$$
i\,\partial_t w_n + \partial_x^2 w_n = f_n
$$

such that for one $0 \leqq b \leqq 1$, we have

$$
i\partial_t w_n + \partial_x^2 w_n = f_n
$$

for one $0 \leq b \leq 1$, we have

$$
||w_n||_{X_T^{0,b}} \leq C, ||w_n||_{X_T^{-1+b,-b}} \to 0 \text{ and } ||f_n||_{X_T^{-1+b,-b}} \to 0.
$$

Moreover, we assume that there is a non empty open set ω *such that* $w_n \to 0$ *in* $L^2([0, T], L^2(\omega))$.

Then $w_n \to 0$ *in* $L^2_{loc}([0, T], L^2(\mathbb{T}))$ *.*

We want to apply this lemma with $b = 1/2$ and

$$
f_n = -\partial_x P_+ \left[W_n (P_- \partial_x u_n) \right] - \frac{i}{2} P_+ \left[g_n e^{-\frac{i}{2} F_n} \right]
$$

$$
- \frac{1}{4} P_+ \left[\left(-\frac{1}{2} P_0 (u_n^2) + G_n \right) u_n e^{-\frac{i}{2} F_n} \right]
$$

$$
u_n, G_n = \partial_x^{-1} g_n.
$$
 That is, we need to prove

$$
u_n^{\frac{1}{2}} \leq C, \quad ||w_n||_{v_n^{-\frac{1}{2}, -\frac{1}{2}}} \to 0 \quad and \quad ||f_n||_{v_n^{-\frac{1}{2}, -\frac{1}{2}}}
$$

with $g_n = \mathcal{G}\mathcal{G}^*u_n$, $G_n = \partial_x^{-1}g_n$. That is, we need to prove

$$
||w_n||_{X_T^{0,\frac{1}{2}}}\leq C, ||w_n||_{X_T^{-\frac{1}{2},-\frac{1}{2}}}\to 0 \text{ and } ||f_n||_{X_T^{-\frac{1}{2},-\frac{1}{2}}}\to 0.
$$

We decompose $f_n = f_n^a + f_n^b$ with $f_n^a = -\partial_x P_+ [W_n (P_-\partial_x u_n)]$. We know that

- $||w_n||_{X^{0,1/2}} \leq C$,
- $|| f_n ||_{Y^{0,-1/2}} \leq C$.

Lemma 7.5. *For any* $\theta \in [0, 1]$ *, we have the bound*

$$
||f_n||_{X_T^{-2\theta,-\frac{1-\theta}{2}}} \leqq C.
$$

Proof. If we prove $||f_n||_{X_T^{-2,0}} = ||f_n||_{L^2([0,T],H^{-2})} \leq C$, by interpolation, this gives

$$
||f_n||_{X_T^{-2\theta,-\frac{1-\theta}{2}}} \leqq C.
$$

So, to bound f_n^a , we need to prove that $W_n(P_-\partial_xu_n)$ is bounded in $L^2([0, T], H^{-1})$. We write

$$
||W_n(P_{-\partial_x u_n})||_{L^2([0,T],H^{-1})} \leq C ||W_n||_{L^2([0,T],H^1)} ||\partial_x u_n||_{L^{\infty}([0,T],H^{-1})}
$$

\n
$$
\leq C ||w_n||_{L^2([0,T],L^2)} ||u_n||_{L^{\infty}([0,T],L^2)} \leq C
$$

where we have used that H^1 is an algebra and so by duality, $H^1 * H^{-1} \hookrightarrow H^{-1}$.

The bound for f_n^b is easier (and corresponds actually to the estimates of *II* and in Section 3.1) *III* in Section [3.1\)](#page-12-6)

$$
\begin{aligned}\n\|f_n^b\|_{L^2([0,T],H^{-2})} &\leq \|f_n^b\|_{L^2([0,T],L^2)} \leq \|g_n\|_{L^2([0,T],L^2)} \\
&\quad + \left\| -\frac{1}{2}P_0(u_n^2) + G_n \right\|_{L^\infty([0,T]\times\mathbb{T})} \|u_n\|_{L^2([0,T],L^2)} \\
&\leq \|g_n\|_{L^2([0,T],L^2)} + \left(\|u_n\|_{L^\infty([0,T],L^2)}^2 + \|g_n\|_{L^2([0,T],L^2)}\right) \|u_n\|_{L^2([0,T],L^2)}.\n\end{aligned}
$$

With for instance $\theta = \frac{1}{5}$,

$$
||f_n||_{X_T^{-\frac{2}{5},-\frac{4}{10}}} \leqq C.
$$

So, since $-\frac{1}{2} < -\frac{2}{5}$ and $-\frac{1}{2} < -\frac{4}{10}$, the embedding of $X_T^{-\frac{2}{5}, -\frac{4}{10}} \hookrightarrow X_T^{-\frac{1}{2}, -\frac{1}{2}}$ is compact and we can extract a subsequence and pick a function *f* such that

$$
||f_n - f||_{X_T^{-\frac{1}{2}, -\frac{1}{2}}} \to 0.
$$

We can get that $f = 0$ using the equation verified by w_n , f_n and use the fact that we already know that $w_n \rightharpoonup 0$ in the distributional sense.

$$
||f_n||_{X_T^{-\frac{1}{2},-\frac{1}{2}}} \to 0.
$$

This constitutes the case $b = \frac{1}{2}$. The same holds for w_n .

We can now state the following theorem.

Theorem 7.2. *Under the same assumptions as in Lemma [7.1,](#page-31-1) we have* $u_n \to 0$ *in* $L_{loc}^2([0, T], L^2(\mathbb{T}))$

Proof. Using Theorem [7.1](#page-34-0) and the previous analysis, we get $w_n \to 0$ in $L^2_{loc}([0, T]$, *L*²(T)). By definition of w_n , we have $w_n = -\frac{i}{2}P_+(u_n e^{-\frac{i}{2}F_n})$. However, we have proved in Lemma [7.2](#page-32-1) that $e^{-\frac{i}{2}F_n}$ converges strongly to 1 in $L^{\infty}([0, T], L^{\infty})$, so we can write

$$
P_+u_n=2iw_n-P_+\left[u_n\left(e^{-\frac{i}{2}F_n}-1\right)\right].
$$

This gives $P_+u_n \to 0$ in $L^2_{loc}([0, T], L^2(\mathbb{T}))$ and the same result for u_n since u_n is real valued. \square

7.2. Small Data

Lemma 7.6. *For* $u_0 \in L^2(\mathbb{T})$ *, let u denote the solution of*

$$
\begin{cases} \partial_t u + \mathcal{H} \partial_x^2 u = u \partial_x u - \mathcal{G} \mathcal{G}^* u, \\ u(0) = u_0, \end{cases}
$$

and let uL denote the solution of

$$
\begin{cases} \partial_t u_L + \mathcal{H} \partial_x^2 u_L = -\mathcal{G} \mathcal{G}^* u_L \\ u_L(0) = u_0. \end{cases} \tag{7.1}
$$

Then, there exist some constants $T_0 > 0$, $\varepsilon > 0$ *and* $C > 0$ *such that for* $T < T_0$ *and* $||u_0||_{L^2} \leq \varepsilon$ *, we have*

$$
||u - u_L||_{L^{\infty}([0,T],L^2)} \leqq C ||u_0||^2_{L^2}.
$$

Proof. Let v denote the solution of

$$
\begin{cases} \partial_t v + \mathcal{H} \partial_x^2 v = -\mathcal{G} \mathcal{G}^* u \\ v(0) = u_0. \end{cases}
$$
 (7.2)

From [\(4.2\)](#page-21-2) applied with $g = -\mathcal{G}\mathcal{G}^*u$ and $||u_0||_{L^2}$ small enough, we have

$$
\|u - v\|_{L^{\infty}([0,T],L^2)} \lesssim \|gg^*u\|_{L^2([0,T],L^2)}^2 + \|u_0\|_{L^2}^2
$$

\n
$$
\lesssim \|u\|_{L^2([0,T],L^2)}^2 + \|u_0\|_{L^2}^2
$$

\n
$$
\lesssim C_1(T+1) \|u_0\|_{L^2}^2
$$
\n(7.3)

for some constant $C_1 > 0$ where we used the fact that $||u(t)||_{L^2} \le ||u_0||_{L^2}$ for any $t \geq 0.$

On the other hand, by classical semigroup estimates we have that

$$
\|v - u_L\|_{L^{\infty}([0,T],L^2)} \lesssim \|gg^*(u - u_L)\|_{L^1([0,T],L^2)}
$$

\n
$$
\lesssim \|u - u_L\|_{L^1([0,T],L^2)}
$$

\n
$$
\leq C_2 T \|u - u_L\|_{L^{\infty}([0,T],L^2)}.
$$
\n(7.4)

Combining [\(7.3\)](#page-36-0) and [\(7.4\)](#page-36-1) and the triangle inequality yield

$$
||u - u_L||_{L^{\infty}([0,T],L^2)} \leq C_1 ||u_0||_{L^2}^2 + C_2 T ||u - u_L||_{L^{\infty}([0,T],L^2)}.
$$

Thus

$$
||u - u_L||_{L^{\infty}([0,T],L^2)} \leq \frac{C_1 T}{1 - C_2 T} ||u_0||_{L^2}^2
$$

whenever $||u_0||_{L^2} < \varepsilon$ and $T < T_0 = \frac{1}{2C_2}$. \Box

Proposition 7.1. *Suppose* $u_{n,0}$ *is a sequence of smooth functions strongly convergent to* 0 *in L*²*, with associated solutions un of the problem*

$$
\begin{cases} \partial_t u_n + \mathfrak{H} \partial_x^2 u_n = u_n \partial_x u_n - \mathfrak{G} \mathfrak{F}^* u_n \\ u_n(0) = u_{0,n}, \end{cases}
$$

and in addition assume that

$$
\|\mathcal{G}u_n\|_{L^2([0,T]\times\mathbb{T})}\leq \frac{1}{n}\|u_{0,n}\|_{L^2}.
$$
\n(7.5)

Then, $u_{0,n} = 0$ *for n large enough.*

Proof. We denote $u_{n,L}$ the solution of

$$
\begin{cases} \partial_t u_{n,L} + \mathcal{H} \partial_x^2 u_{n,L} = -\mathcal{G} \mathcal{G}^* u_{n,L} \\ u_{n,L}(\mathbf{0}) = u_{0,n}. \end{cases}
$$

By the observability of the linear damped system, proved in [\[29](#page-43-14)] Theorem 1.2, we know that for some *T* that can be chosen $T < T_0$, we have

$$
||u_{0,n}||_{L^2}^2 \leq C \int_0^T ||\mathcal{G}u_{n,L}||_{L^2}^2.
$$
 (7.6)

But, we have from triangular inequality, [\(7.5\)](#page-36-2) and Lemma [7.6,](#page-35-1) that

$$
\| \mathcal{G} u_{n,L} \|^2_{L^2([0,T] \times \mathbb{T})} \leq C \| \mathcal{G} u_n \|_{L^2([0,T] \times \mathbb{T})}^2 + C \| \mathcal{G} (u_{n,L} - u_n) \|_{L^2([0,T] \times \mathbb{T})}^2
$$

$$
\leq \frac{C}{n} \| u_{0,n} \|_{L^2}^2 + C \| u_{0,n} \|_{L^2}^4.
$$

Combining the previous estimate with (7.6) gives

$$
||u_{0,n}||_{L^2}^2 \leq C \left(\frac{1}{n} + ||u_{0,n}||_{L^2}^2 \right) ||u_{0,n}||_{L^2}^2.
$$

Since $||u_{0,n}||_{L^2}$ converges to zero, this gives $u_{0,n} = 0$ for *n* large enough. \square

8. Stabilization

In this section we will prove Theorem [1.2.](#page-5-0) We will use the argument in [\[31](#page-43-0)]. However to complete the arguments we have to make some modifications as we did in the previous section.

Because of the identity

$$
\frac{1}{2}||u(t)||^2 + ||\mathcal{G}u||^2_{L^2([0,T]\times\mathbb{T})} = \frac{1}{2}||u_0||^2
$$
\n(8.1)

we observe that $||u(t)||$ is nonincreasing, so that the exponential decay is guaranteed if

$$
||u((n+1)T)|| \le \kappa ||u(nT)|| \text{ for some } \kappa < 1.
$$

To prove the theorem, it is sufficient to show the following observability inequality: for any $T > 0$ and any $R \gg 1$ there exists a constant $C(R, T)$ such that for any $u_0 \in H_0^0(\mathbb{T})$ with $||u_0|| \leq R$ it holds

$$
||u_0||^2 \le C \int_0^T ||\mathcal{G}u(t)||^2 dt
$$
 (8.2)

where u denotes the solution of (1.12) .

Suppose there exists a sequence $u_{0,n} \in H_0^0(\mathbb{T})$ such that for each *n* we have $||u_{0,n}|| \leq R$ (where $R \gg 1$) but

$$
||u_{0,n}|| > n \int_0^T ||\mathcal{G}u_n(t)||^2 dt.
$$
 (8.3)

Then from Theorem [7.2,](#page-35-0) we have for a subsequence (still denoted by u_n) that

 $u_n \to 0$ in $L^2_{loc}([0, T], L^2(\mathbb{T})).$

Thus one can select some $t_0 \in (0, T)$ such that, extracting again a subsequence,

$$
u_n(t_0) \to 0
$$
 in $L^2(\mathbb{T})$.

Since

$$
\frac{1}{2}||u_n(t_0)||^2 + ||\mathcal{G}u_n||^2_{L^2([0,t_0]\times\mathbb{T})} = \frac{1}{2}||u_{0,n}||^2,
$$

we conclude that

$$
||u_{0,n}||_{L^2} \to 0.
$$

The assumptions of Proposition [7.1](#page-36-3) are fulfilled. We finally get $u_{0,n} = 0$ for *n* large enough, which is a contradiction to [\(8.3\)](#page-37-2).

Appendix

In the following, we will establish a slight modification of the bilinear estimate of Molinet-Pilod [\[37\]](#page-44-0), Proposition 3.5, with a gain of a power of *T* . Such an estimate will allow us to avoid the dilation argument for small time and large data and it could also be interesting for other purposes. This type of gain was already obtained by BOURGAIN in [\[7\]](#page-42-8) for the KdV equation and it relies mainly on the fact that the equation we consider is subcritical on L^2 with respect to the scaling.

$$

where $dv = d\xi d\xi_1 d\tau d\tau_1$, $\xi_2 = \xi - \xi_1$, $\tau_2 = \tau - \tau_1$, $\sigma = \tau - \xi |\xi|$ and $\sigma_i = \tau_i - \xi_i |\xi_i|$, $i = 1, 2$ and
 $\mathcal{D} = \{(\xi, \xi_1, \tau, \tau_1) \in \mathbb{R} : \xi > 1, \xi_1 \ge 1$ and $\xi_2 \le 0\}$. $\tau_i - \xi_i |\xi_i|, i = 1, 2$ and

\mathcal{D} = \{ (\xi, \xi_1, \tau, \tau_1) \in \mathbb{R} : \xi > 1, \, \xi_1 \geq 1 \text{ and } \xi_2 \leq 0 \}.

and

$$
J_{N,N_1,N_2} = \sum_{N} \int_{\mathcal{D}} \frac{\xi}{\langle x\sigma \rangle^{1/2}} g_N(\xi,\tau) \phi_N(\xi) \, \xi_1^{-1} \widehat{P_{N_1}w}(\xi_1,\tau_1) \xi_2 \, \widehat{P_{N_2}u}(\xi_2,\tau_2) \, \mathrm{d}\nu.
$$

Let us now consider

A_{N,N_2} = \left\{ (\xi, \xi_1, \tau, \tau_1) \in \mathcal{D} : |\sigma| \geq \frac{1}{6} N N_2 \right\}
$$

\n
$$
B_{N,N_2} = \left\{ (\xi, \xi_1, \tau, \tau_1) \in \mathcal{D} : |\sigma_1| \geq \frac{1}{6} N N_2, |\sigma| \leq \frac{1}{6} N N_2 \right\}
$$

\n
$$
C_{N,N_2} = \left\{ (\xi, \xi_1, \tau, \tau_1) \in \mathcal{D} : |\sigma| < \frac{1}{6} N N_2, |\sigma_1| < \frac{1}{6} N N_2, |\sigma_2| \geq \frac{1}{6} N N_2 \right\}.

Lemma A.1. *We have for* $0 \leq T \leq 1$ *the estimate*
